Summer School and camps: These programs are four-week full-day academic programs for at-risk youth in various communities in the Dominican Republic. In addition to core educational subjects designed to reverse drop-out rates and risky behaviors, the programs provide traditional camp activities and field trips for the children.

Year Long Youth: Young Stars is a program providing leadership and literacy courses in an extracurricular format for at-risk adolescents during the school year. Deportes para la Vida is an HIV/AIDS prevention program that uses soccer, games, and peer mentoring to engage youth in the creation and practice of healthy life choices.
